28 Passion 4 People Spread the Gospel with over 15,600 individuals, trained another 1880 people in life-style witness and gave physical and medical care to over 1000 people living in the slums in India. In addition, P4PI helped provide instruction and mentoring to 43 evangelists in Hyderabad, India. P4PI also helped ship 1000's of books and other literature to India to help equip leaders and urban youth. P4PI President Brad Butcher spoke at least once a month at difference churches to raise awareness and passion for the struggling people in the 10/40 window resulting in teams coming to India as well as raising financial support. P4PI created two new websites to advance the cause and produced 2 videos. In October P4PI helped put on Rock of Ages Festival 2011 reaching nearly 10,000 people in Northern California. In November P4PI helped put on the Franklin Graham Hyderabad Festival resulting in over 200,000 people hearing the Gospel. Overall 2011 was a very active and successful year for P4PI. One of the biggest highlights was sending a family to India to lay the ground work for an office and coffee shop training center there in the near future.
