

Each member was asked to comment on the Form 990 before it was submitted for signature to the organization's president and subsequently filed.

Part VI, Section B, line 12b --- The organization regularly and consistently monitors compliance with conflicts of interest by routine meetings attended by all trustees and, frequently, key employees. The nature of the organization's activities is such that conflicts of interest are not likely to occur. This answer is provided even though "No" is the correct response to question 12a. The trustees of Lehman Avenue Evangelize consider a whistle-blower policy as unnecessary. Additionally, there is no document retention and destruction policy other than the policy to maintain records suitable for compliance with IRS rules, regulations and requirements for record-keeping purposes.

Part V, question 1c --- "Yes" is answered to this question even though the organization was not subject to backup withholding rules for reportable payments to vendors and reportable gaming winnings to prize winners.

Part VI, Section B, line 15b --- None of the organization's trustees or officers are compensated. The only "key employees" are ministers whose remuneration is made in accordance with guidance for ministers' compensation as established in IRS rules, regulations and other guidance. Ministers' remuneration is set by trustees after careful consideration of responsibilities, expectations and comparability data; and contemporaneous substantiation of the deliberation process and decisions is made.

Part VI, Section C, line 19 --- All records of the organization are available for public inspection if the inquiring party has a legitimate interest in supporting the organization's mission or there is otherwise a need to know.

Part V, question 2b --- The organization's "employees" are remunerated as ministers, in accordance with IRS guidelines. As such, they are not subject to withholding for Social Security and medicare taxes and/or federal and state income tax withholding. Accordingly, quarterly filing of forms 941, etc. is not applicable.
