World Orphans' belief is that the best place for a child is in a family - ideally the birth family - but extended family, foster care or a church-based children's home are all solutions that allow the child to remain immersed within their community. World Orphans' indigenous church partners work within a model of orphan care we call the Continuum of Care that seeks to provide for the needs of the whole child - physical, mental, emotional and spiritual. This is primarily accomplished through the establishment of indigenous church-based orphan prevention, residential, and self-sustainability programs. Examples of programs include home based care, church based foster care programs, and secondary educational support. During the period 1/1/2011 - 12/31/2011, World Orphans helped to fund 50 projects in 17 countries for the support of orphans. It is estimated that 3,169 children were impacted through this program. In addition, World Orphans organized or sponsored 11 medical clinics that provided care to 4,718 patients in underserved areas.
