 To end the #1 cause of suffering & death for dogs & cats (overpopulation), by developing special food that can sterilize them without surgery, allowing for population control without euthanasia and without killing; To alleviate the #1 financial burden of humane societies (managing dog/cat overpopulation); To save human lives by dramatically reducing the #1 cause of the 55,000 human deaths from rabies each year: infected stray dogs. In our work No animals are harmed, and we give our animals lifetime care.

FORMULA INVESTIGATION: We collaborated with experts in many fields of science: medical doctors in fertility, internists, biologists, surgeons, endocrinologists, veterinarians, chemists, biochemists, nanotechnologists, compound pharmacists, physiologists, et al.; we identified over 100 biological agents, minerals, formulas, drugs & metallic chemical elements (such as Zinc) which can cause non-surgical birth control in animals & or humans, we investigated these & focused on long lasting or permanent oral birth control formulas that: A) Will be capable of replacing spay and neuter surgery, B) Will not require capturing or injecting animals, C) Will be cost-effective, D) Will be capable of ending the global stray dog & cat overpopulation without euthanasia, without killing, without surgery, and without suffering. We investigated the major problems resulting from the uncontrolled reproduction of strays & the impact this has on society such as causing human deaths (due to canine rabies), inhumane mass killings of strays around the world, and costly attempts to control dog & cat populations (estimated at over 1 billion dollars each year in the U.S.), we verified amongst other things, that the main international animal population control methods (mass killings, euthanasia, adoptions, spay & neuter surgery, etc) are cost prohibitive, too labor intensive & time consuming, and bottom line ineffective and despite mass killings, etc. the number of strays worldwide rises each year, with the rise of their primary food source: human garbage.

4b (Code:) (Expenses \$ 130,332 including grants of \$ 40,000) (Revenue \$ 0)
Canine Formula Trial Preparations: Our mission includes delivering long lasting oral birth control for species whose overpopulation is a problem for people and animals; to expedite the process & for scientific reasons we began with formulas for dogs, cats are next, followed by wildlife species; we focused on ensuring the formulas are safe and effective, and that they can be administered without posing a risk to the health or well being of animals or people who may accidentally come into contact with the formulas; thus far our investigations have found that when used as intended, the formulas do meet these criteria: they do not harm animals, they do not harm people, they can be safely administered, they do not harm the environment, because active ingredients such as Zinc, will need to be eaten only once in a lifetime, they thus far have shown no negative side-effects when used as intended; we made extensive preparations & commissioned the implementation of scientific clinical trials on the formulas which our scientists believe are the most effective, we have ensured that: No animals are harmed in our work; No animals are destroyed or euthanized; We provide life-time care for the animals we treat; they are adopted into pre-screened caring homes and remain under our care, for their life time, the organization's scientists believe they are close to completing the first finished oral canine formula, based on extensive work thus far, and that the primary obstacle has been and is, the lack of personnel and staffing.

4c (Code:) (Expenses \$ 32,583 including grants of \$ 0) (Revenue \$ 0)
Rabies Impact on Humankind, and Education: Another aspect of the mission is to deliver a solution to the problem of human deaths from rabies; the World Health Organization reports that: (A) Over 55,000 people die every year from rabies, (B) The majority of victims are children, (C) The majority of human infections come from stray dogs; (D) The way to control human deaths from rabies is to control the population of stray dogs. This last finding by the W.H.O. is exactly our mission and we developed a strategy to deliver a formula that our scientists believe will be capable of dramatically reducing human deaths from rabies, humanely, instead of killing dogs, which is the primary form of rabies control in approximately 49 countries. Though hindered by a lack of staff, the organization none the less developed a strategic plan to have the first formula, in limited use in 5 countries (where rabies & the mass killings of strays are the most severe), within five years of finishing the first formula; the plan includes working directly with government-run rabies control agencies; because the organization has no staff and relies on volunteers, we developed a network of volunteer scientists, activists and supporters to coordinate and cooperate in these investigations and in creating, and carrying out these strategies; we rely on education and outreach mailings to the community to recruit our volunteer "staff", we have partnered and or collaborated with other organizations in addition to building grass roots support; continued in Schedule O.
