Head Lama of TNMC Yeshe De Project books are freely given to monastic and lay participants.

 In Feb of 2011, \$250,000 was sent to Head Lama of TNMC who sent all these funds to Bodh Gaya for the 2011 ceremony, held in Feb. \$175,709 was spent in offerings to the assembly of 150 Head Lamas and Tulkus, and 7000 monks and nuns. \$46,812 was spent on 1 million butterlamps offered during the 10 day ceremony, as well as on temple lighting during the ceremony. \$8,552 was spent on puja offerings such as tsog (ceremony food for 10,000 people), and flowers \$5,542 was spent on tent rentals and food \$4,085 was spent for meals for 2000 beggars, rice, tea, vegetables, and flat bread \$12,583 was spent on other offerings during the ceremony \$2,632 was spent on prayerwheels given to nuns
 This list totals \$255,916, the \$5,916 having been contributed by TNMC, outside of the Bodhgaya funds herein. TNMC also contributed books and other funds that were distributed during the ceremony.

4b (Code:) (Expenses \$ 1,017,395.63 including grants of \$ 1,017,395.63) (Revenue \$)
 Feb 2011, these funds were sent to Head Lama of TNMC who sent them to India to finance butter lamp offerings daily year long in perpetuity at Bodh Gaya in the butter lamp houses at the Bodh Gaya stupa. \$1,000,000 was to endow the lamps in perpetuity, and the balance was to pay for materials and labor owed to date, as well as legal and filing fees. During 2011, 3000 - 5000 lamps were offered daily. In 2011 alone, \$64,555 was spent on year-long butter lamp offerings.
