Mission Outreach Program: Assistance in the form of donated materials was given to 34 projects this year in the United States and 14 other countries. Australia, Brazil, China, India, Japan, Mexico, Philippines, Peru, Serbia, Spain, South Africa, Taiwan, Thailand and Togo. Event highlights include: Donations of food, medical supplies, blankets, mosquito nets, hygiene kits and children's books were given to the victims of the 2011 Japan Tsunami. These items were delivered by local volunteers on eight separate missions to the affected areas. Activated Ministries sponsored a three-day children's camp which was attended by over 100 orphans during the Christmas season in Durban, South Africa. Activated Ministries provided 4,500 educational poster sets and 900 children's books to be distributed by "Patricino un Libro" volunteers to indigenous communities within the states of Oaxaca and Hidalgo, Mexico. In Mexico City, we sponsored 1,000 books which volunteers distributed to 3 orphanages, 1 hospital, a refuge for battered and destitute women, and a group of child burn victims. In addition to the large scale book distribution projects, "Patricino un Libro" volunteers also hosted a series of educational seminars for parents, teachers and educators. Schools in war torn villages in Kosovo and Serbia received donations of 1,500 Early Learning curriculums in their own language. The translation, printing and shipping of the Early Learning curriculums and materials were sponsored by Activated Ministries. Online, Telephone and Mail Outreach Programs: In 2011 Activated Ministries sponsored a project to build an online Bible study and Christian teaching website to reach out to new Christians around the world. Also in 2011 we set up a new Facebook page called "Get Activated Today!" where we publish and promote devotional and inspirational articles in both English and Spanish. Throughout 2011 we mailed over 10,000 mailings with Activated magazines, devotionals, Bible Study helps and other discipleship instructional materials.
