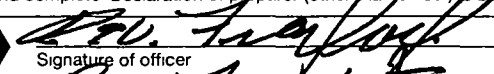
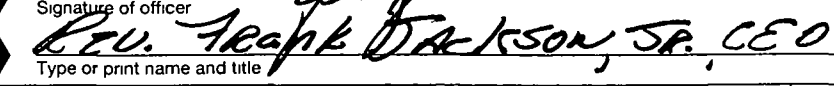

 Building a Better Community Initiative - The Building A Better Community Initiative program and team serves the community by providing affordable housing opportunities, job opportunities, and small business opportunities through the purchasing of REO properties via its collaboration with JPMorgan Chase, Wells Fargo Bank, and CITI Bank. The Organization acquired 56 properties for restoration and resale to low-to-moderate income families. The BBICI Seed Project's Financial Wellness program held monthly workshops focused in the areas of household budgeting, financial stewardship, credit as a tool, the FDIC's "Money Smart" and the Wells Fargo "Hands On Banking" programs. "Train-the-trainer" workshops were conducted in collaboration with our stakeholder and community partners based on the needs of the target cohort. Sessions were held in one-on-one, and small group settings. The curriculum incorporates a three prong assessment (1) What Is The State of the Organization, (2) What Is the State of Congregation and/or Client Served, and (3) What is The State of the Community. The program focuses on FBO Pastors and Lay Leaders, and CBO Executive Directors, Board Members, and Key Staff assisting them in identifying the Organizations (1) Strengths, (2) Weaknesses, (3) Opportunities, and (4) Threats ("SWOT Analysis"). Utilizing its network of multi-ethnic, multi-culture, and multi-faith community and stakeholder collaborations the Organization was able to identify 35% of its 2011 Low-to-Moderate Income Buyers.

 Pathway to The Future & College Bound Program - The program identified participants in the beginning of their middle school years and supports them through their high school and college career of personal growth and exploration. The program engages the parents, public educators, CBO and FBO as community and stakeholder partners. The objective, (1) to guide each participant in establishing a clear and realistic understanding of family values, spiritual enrichment, personal health, community responsibility, social, and leadership development, (2) coach, mentor, and direct participants along paths of self-exploration, improvement, and development resulting in discoveries of latent creativity and a desire to excel beyond their community silos where, for most of the participants, the vision of opportunity is gang membership, drugs, teenage motherhood and fatherhood, joblessness, hopelessness, and entrapment by low self-expectations, and (3) increase participant's expectations, academic skills, and confidence in self, family, community, and education system. Participants matriculate through a four phase curriculum, Phase I - Personal and Social Development, Phase II - Leadership, Mentoring and Team Building, Phase III - Economic Development and Community Development, Phase IV - Development Of Career Choices.

The deliberations are held in closed sessions and the results are conveyed in writing. The Secretary of the Board of Directors maintains notes of the discussions of the Executive Sessions. The President and CEO determines the salary for the key employees within the constraints of the approved budget and based upon the annual performance evaluation.

Form 990, Part VIII, Line 10b: For 2011 the Organization purchased \$13,478,478 of properties through the JP Morgan Chase Bank's and Wells Fargo Bank's Neighborhood Stabilization and Revitalization REO Programs. The Organization was approved for the programs in August of 2010 to acquire properties through each of the respective Bank's REO Gifting and Discount Sales Strategy programs. As an approved entity the Organization was mandated to (i) restore purchased properties as part of its Revitalization initiative, and (ii) provide Financial Wellness programs to faith-based and community based organizations, their memberships and participants in their efforts of becoming first-time, and re-entry homeowners' as part of its Stabilization initiative.

With the Banks' approval, the Organization engaged a cohort of Capital Partners and entered into Capital Partners Agreements. The agreements provided the Organization the funds to purchase the properties at a discount with a margin spread to be used to (i) restore the properties, carrying cost, taxes, insurance, and security (w/applicable) an average of 15%, (iii) returned to the capital partners an average of 11%, (iv) passed on to the first-time or re-entry homebuyer an average of 5% equity at close of escrow, and (v) returned to the Organization 2% percent (\$269,569 + \$14,978 = \$284,547) in Program Service Revenue. Items (iii), (iv), and (v) are per transaction. The Organization purchased 56 properties at an average of \$236,464 per property.

Form 990, Part VIII, Line 10a: For 2011 the Organization sold 33 properties. The gross sale of inventory was \$11,260,318 at an average of \$341,221 per property. The 56 properties purchased, and 33 properties sold generated a net loss of -2,218,160 for 2011. The remaining 23 properties purchased in 2011 were sold in 2012. Note: The 2011 net loss from sales did not adversely effect the Program Service Revenue.
