

 Provided 18 water projects within the Trichy District of Tamil Nadu along with funding the construction of 2 community centers to be used for health and hygiene education, after school care, and community education meetings. Provided monthly funding for Annai Erica Public School and Orphanage for books, material, food, teacher salaries and other miscellaneous expenses benefiting 1,000 students. Also helped fund the construction of a dormitory facility for a Infant Jesus Higher Secondary School so that those who didn't have a home and were being boarded in a classroom at the school could have their own residence in a dorm facility. All the work carried out in this area was with our partner Depressed People's Welfare Association. The impact of the water projects, construction projects and monthly support at Annai Erica is estimated to be around 10,000 rural men, women and children.

4b (Code:) (Expenses \$ 110,335.00 including grants of \$ 93,335.00) (Revenue \$ 9,078.00)
 Provided 35 water projects within the East and West Godavari District of Andhra Pradesh thereby positively impacting the lives of at least 19,000 rural villagers. In addition to providing clean, safe drinking water to this area, we also engaged in activities where we provided funding for 200 orphan and semi-orphan children to enjoy Christmas presents and 2 new sets of clothing at New Life Children's Home in Yellamanchilli, assistance was provided to another Children's Home in Chintalapudi for the ongoing expenses and building completion for 45 orphan and semi-orphan children. Financial assistance was also provided for those being negatively affected by HIV/Aids and Leprosy along with funding for a micro lending program run by our partner, Nazareth Assoc. for Social Awareness. Last of all, funding was provided to our N.A.S.A. partner for helping with rural villagers being displaced by natural or man made causes such as rain, flooding or fire with the assistance taking the form of food, clothing and shelter, the basic necessities for human survival.

 Provided 1 deep bore well within the state of Orissa on some property acquired by an Indian NGO, Society for Transformation, Education and Progress. This project was outfitted with both an electric pump and an optional hand pump configuration for the development of the property and once it is development for the drinking water needs of the organization. Estimated impact is 100 people within the immediate area.
