Build a Miracle does not provide grants, but records are maintained regarding the selection criteria and proper use of the homes and scholarships provided to impoverished families and students, respectively. Build a Miracle is a hands-on organization that operates in the community and has first-hand knowledge of the families served. Land deeds or purchase contracts are reviewed to insure that homes are only built on land legally occupied by the families chosen to receive the homes. A record is kept on each family including a photographic history of the homes constructed and the shacks they lived in before. Every expense is backed up by receipts or invoices. Families desiring a home provide a letter describing their situation to a committee of volunteers including many who have received homes in the past, which conducts a preliminary visit and collects additional information about the number of family members, ages, financial resources, special needs, etc. Other charitable organizations in the areas we serve often refer impoverished families to Build a Miracle.
