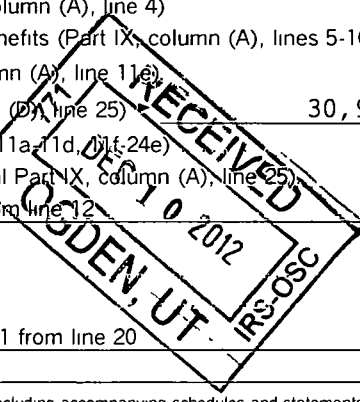

2011 Statement of Program Service Accomplishments

Project Rebirth's Strategic Review

A Living History of the Human Spirit Coping With Disaster

Project Rebirth is a film chronicle of the strength of the human spirit coping with disaster: the aftermath of September 11, 2001 at the World Trade Center. As a feature-length documentary combining 35 MM time lapse photography of the rebuilding of Ground Zero with the intimate stories of nine people coping post 9/11, Rebirth is the only living record of the minute-by-minute rebuilding of the World Trade Center site and the only long term public film record of nine people dealing with grief and trauma. It will be a key component of the National September 11 Memorial and Museum and serve as the basis for a range of cutting edge teaching and learning tools for educational, training and therapeutic programs.

Chronicling Living History to Inform and Empower

Project Rebirth created a feature-length documentary that:

- **Engages global audiences** in a pure, apolitical and productive perspective on individuals' and communities' long term response to a major disaster
- **Inspires and enables viewers and collaborators** to devote energy and resources to:
 - Capturing and making best use of a unique historical record of the recovery from the destruction of the World Trade Center;
 - Expanding the study and delivery of support for victims of mass trauma and grief.

Recording and Archiving History, Creating Powerful Film and Media, Reinvesting to Help Victims of Traumatic Loss

Phase I:

Record in the highest quality media the efforts to cope with and rebuild from the physical and emotional damage caused by the destruction of the World Trade Center.

- Develop the financial and professional resources for a 12-15 year effort to capture the history of the recovery from the 9/11 attacks.
- Raise sufficient funds to ensure that as much as possible of the living history of the World Trade Center rebuild is captured on the highest quality media available: 35 MM motion picture film – *before the opportunities are lost*.

Phase II:

Collaborate with world-class partners to advance projects and initiatives closely aligned with Rebirth's content and mission.

- **Educate and inform, and support** victims of and first responders to major traumatic events
 - **Educate and inform:** e.g. creation of relevant curricula for students in line with Rebirth's mission to "Remember 9/11;" films for and installations in the National 9/11 Museum.
 - **Support:** e.g. content for services, therapies and research focused on disaster and large scale grief and trauma.
 - **Project Rebirth Educational Initiative** formed by leading teaching and learning centers at **Georgetown and Columbia** Universities.

Phase III:

Roll out plans for distribution and presentation of our feature-length documentary in theaters, and across the full range of distribution channels. Coordinated with a nationwide grassroots effort to build awareness for the need to provide improved long terms care for grief and trauma following disasters, presentation of Rebirth's film and media will serve as a call to action for audiences to support the Project Rebirth resiliency building education programs.

Phase IV:

Raise funds to support Project Rebirth education programs for victims of and first responders to mass trauma and grief.

- The Project Rebirth educational programs will develop, gather, improve and redistribute resiliency building/training resources for long term support for victims of and first responders to events of mass trauma and loss.
- This specialized resource will be the first of its kind, meeting and urgent and growing need to leverage existing academic, practical and professional skills and knowledge using leading teaching and learning tools processes.
- In parallel with the global release of Rebirth's feature-length documentary, the development of educational programs to improve long-term care for grief and trauma, directly leveraging Rebirth philanthropic investment and mission.

2011 Review

In 2011, Project Rebirth made significant progress advancing the strategic imperatives outlined above.

The documentary film, REBIRTH, premiered at the Sundance Film Festival in January 2011 and was released in theaters and broadcast on television broadcast in September 2011. The film opened in theaters nationally and on television networks internationally and was viewed by more than 2 million people worldwide. Additionally grassroots/community screenings had more than 20,000 viewers in attendance.

Timelapse filming of the rebuilding of the World Trade Center site continued, as the pace of construction at the site also continued to increase. In September 2011, the 9/11 Memorial opened to the public, while Tower One made significant progress toward completion. Rebirth will continue to film the reconstruction of the World Trade Center Site until it is complete, adding to our unique film library, which will be used for exhibits in the National September 11 Memorial & Museum (NS11MM) as well as for educational, academic and therapeutic purposes.

In 2011, the Project Rebirth film segment created for the 9/11 Memorial Preview Site, a lower Manhattan venue created by the NS11MM to educate the public about the construction of the Memorial and Museum, was seen by millions. The segment was also installed in the 9/11 Memorial Welcome Center, where all visitors to the 9/11 Memorial pass through security and ticketing. In November 2011, work commenced on the Project Rebirth exhibition planned for the future 9/11 Museum at the Memorial site, as well as, nine short films about each of Project Rebirth's participants. These films will be shown at the 9/11 Museum and used for educational, academic and therapeutic purposes.

Plans continue to advance in the development of the Project Rebirth resiliency building education programs and are based on collaborations with the following organizations: the Center for New Designs in Teaching and Learning at Columbia University (CCNMTL), Center New Design in Learning and Scholarship at Georgetown University (CNDLS), New York Police Department, Arlington County Fire Department, Ride 2 Recovery and others. These programs will meet an urgent need to help those who respond to mass casualty events by developing and distributing collaborative on-line teaching and learning tools to help communities be better prepared for the long-term grief and psychological trauma associated with major disasters.
