In 2011, Ogallala Commons, Inc and its community paratners further expanded our Community Internship Program to provide work experience, skill development, and career exploration for 19 High School Students, 24 College Students, and 4 Adults in 40 counties and communities in TX, NM, CO, NE, and KS Secondly, OCI continued extensive work in Youth Engagement by conducting 4 Festivals (first-time events) in TX and NM that involved 27 elementary schools and educated 1,600 students and teachers These Festivals offer comprehensive water education to students as well as opportunities for outdoor activity Another set of events that OCI does regarding Natural Resource Conservation & Education were 4 Playa Field Days in Silverton and Nazareth, TX Together, both events were attended by 98 participants Fourthly, OCI continued its extensive work in Rebuilding Local Food Systems by launching a weekly education blog called Local Llano and by conducting the 23rd Annual Southern Plains on the topic of Community Health, which was attended by 110 participants
