Essilor Vision Foundation (EVF) Form 990 Statement A for reporting year 2011

Program Service Accomplishments

Essilor Vision Foundation (EVF) operates two models of vision screenings, eye exams and glasses in multiple areas around the U.S. The Mission is "to eliminate poor vision and its lifelong consequences," and currently is aimed at elementary school children from families which have income of less than 2x the Federal Poverty level and are not covered by vision insurance.

The Kids Vision for Life (KVFL) program involves a large group of low-income schools, usually within school districts or regions. In collaboration with partners from related non-profit organizations and community-oriented companies, EVF provides vision screening (or assistance to school nurses assigned to do screening), and for those children who do not pass screening, we offers eye exams with doctors of optometry at the school site, often in a mobile vision clinic outfitted with a doctor's office and glasses-making equipment. The optometrist writes a prescription, the child is offered free high-quality frames fitted with high quality polycarbonate lenses suitable for active children. In some cases, EVF is able to make the glasses on-site within the same day. Other more complex prescriptions are sent to a lab. An optician, or school nurse in some cases, fits the glasses to the child and gives instructions on use and care. When possible, there is a follow-up later to assure the glasses are helping the child. This model relies heavily on paid staff, paid doctors and opticians, as well as many trained and certified volunteers, and untrained volunteers. During 2011, this provided 7,725 pairs of glasses at 209 schools and 15 special events. 23,260 children were screened. Most KVFL activity during 2011 was in Dallas, Tarrant, Harris and Travis Counties in Texas and in St. Louis, Missouri. Some work was done with children in the Dallas County Juvenile Justice Centers, where it was noted that over 70% of the residents showed an uncorrected vision problem, compared to 24% in ordinary inner city populations of that age range. 2011 Expenses: \$1,223,491

The Adopt-A-School projects rely heavily on volunteers for vision screenings and clinics, and many of the eye doctors working under this model are also volunteers. The process is similar to the KVFL model, but is generally with one or two schools in an area where interested persons are available to organize and carry out the project. The finishing of glasses is done at a remote lab in all cases, and sent back to the schools or opticians for final fitting and instructions. During 2011, 10,152 children were screened under this model, resulting in 1,334 pair of glasses dispensed. 2011 Expenses: \$ 48,178

In both models, children with high prescriptions are given a second spare pair to be kept by the school nurse in case the child loses, breaks or forgets their glasses, without which their learning will be impaired. Doctors noting disease or other pathologies in an eye will refer the child to an ophthalmologist for further examination. All services and glasses were free of charge to the children and their families or the school.

Services are also offered at health fairs, an annual Kids Vision Fest, and other venues such as the Texas Book Festival where there is a connection to literacy, health or education. In all cases, there is a concerted effort to help parents, teachers, and those dealing with children to understand the connection between good vision and performance in school, athletics, and in behavior. Research is a component in certain locations to affirm the effort is effective. EVF promotes the idea that a strong society depends on economic productivity, which relies on a well-educated population with a low rate of criminal behavior. Poor vision can lead to an under-educated child with a propensity for trouble with the justice system. EVF also cooperates in providing its services to many Special Olympics programs.
