THE EARLY CHILDHOOD RESOURCE CENTER (ECRC) IS A MINISTRY OF THE SISTERS OF CHARITY OF ST. AUGUSTINE. ECRC IS DEDICATED TO IMPROVING THE QUALITY OF CHILDCARE IN STARK COUNTY AND IN 2011 HAS EXPANDED THEIR PROGRAMS TO SEVERAL SURROUNDING COUNTIES WITHIN THE STATE OF OHIO. THIS IS ACCOMPLISHED BY PROVIDING TRAINING AND NETWORKING OPPORTUNITIES AS WELL AS AN EXTENSIVE RESOURCE LIBRARY TO MEMBERS. THE MEMBERS CONSIST OF FAMILIES WITH YOUNG CHILDREN, CHILD CARE STAFF AND COMMUNITY AGENCIES SERVING FAMILIES WITH YOUNG CHILDREN. IN 2011 ECRC CONDUCTED 153 WORKSHOPS TO 2,642 PARTICIPANTS AND 33 CAREER DEVELOPMENT TRAINING CLASSES. CAREER DEVELOPMENT TRAINING (CDA) CLASSES WERE PROVIDED TO CHILDCARE WORKERS WHO ARE WORKING TO ATTAIN THEIR CDA CREDENTIALS. IN 2011, 15 CHILDCARE WORKERS COMPLETED THE CDA CLASSES. ECRC MAINTAINS A PRODUCTION LAB THAT IS AVAILABLE TO ALL MEMBERS FOR A NOMINAL ANNUAL FEE. MEMBERS CAN USE THE LAB TO PROVIDE EDUCATIONAL AGE APPROPRIATE MATERIALS AND ACTIVITIES FOR PRESCHOOL CHILDREN. IN 2011, 534 CHILDCARE CENTERS AND INDIVIDUAL MEMBERSHIPS WERE USED BY OVER 1200 INDIVIDUALS. ECRC ALSO PROVIDES
