Core competencies include activities associated with applied research, public policy analysis and advocacy, communications, and community affairs These activities are essential to the effective operation of the Organization In 2011, major activities by work area included the Board of Directors and Administration providing oversight to the program and operations of the Organization ensuring integrity to the mission and financial stability They monitored progress on the five, five-year program priorities they selected in late-2009 and gave special attention to planning for implementation of the fund development plan, which looks ahead to the Organization’s 100th anniversary The Research team published reports, including Estimation of Small-Area Prevalence of Mental Disorders in Cuyahoga County, Ohio, and The Foreign Born Population in the Cleveland-Akron-Elyria Consolidated Statistical Area A Demographic, Geographic, and Socioeconomic Profile The Research function was significantly enhanced through the creation of a new Data Collaborative with partners at Case Western Reserve University and Cleveland State University’s Levin College of Urban Affairs Through the new collaborative, a major update of the NEOCANDO system was initiated The Public Policy team conducted sound, nonpartisan analysis of public policy as it evolved, framed issues, and provided reliable recommendations to inform and assist legislators, policy and decision makers, nonprofit executives and advocates, and the public about the health, social, and economic welfare of Northeast Ohioans These efforts included publishing significant analyses regarding such issues as health care reform, mental health funding and service provision, and the critical deficit facing the State of Ohio
