The International Institute of Akron is a non-profit agency that provides services to the foreign-born in Akron and the Summit County, Ohio community. IIA's mission is to contribute to the well-being of our community by creating and implementing programs and services to assist the foreign-born to integrate into our society, to promote public awareness of the value of ethnic diversity and to encourage international communication.

Refugee Resettlement and Assistance Programs

As an affiliate of the U.S. Committee for Refugees & Immigrants (USCRI), these programs provide comprehensive services for refugees, asylees, victims of trafficking and secondary refugees who relocate from other U.S. states. Services include case management, financial assistance, English for Speakers of Other Languages (ESOL) classes, employment counselors, appropriate housing arrangements, medical assistance and screenings, assistance with utilities, home visits and referrals for children. The primary goal is to help individuals acquire a working knowledge of the English language, gain employment and achieve self-sufficiency as they adjust to their new life in Akron, Ohio. In 2011, 297 primary refugees and 280 secondary refugees were resettled in Akron and over 600 individuals attended classes at IIA. These services are funded through County, State and Federal contracts.

Communication Services

Interpreting, translation and cultural competency services are offered to assist immigrants, refugees and service providers of the Greater Akron area to overcome language and cultural barriers in communication. The Institute provides trained interpreters, proficient in over 50 languages, to government offices, courts, law enforcement, health care providers and businesses. Emergency interpreting is available 24 hours per day. IIA sponsors an interpreter training program for legal and medical terminology, skill-building and professional ethics in this field. IIA also provides custom cultural competency programs to businesses and the community for better understanding of our diverse community. In 2011, IIA provided 1,150 non-refugee interpreting hours in response to the need in Akron. A total of 115 documents were translated. These programs are funded through fees for service and County contracts.

Other Corporate Activities

Other corporate activity includes immigration counseling services, citizenship preparation and services and a variety of other programs and services funded by United Way, private donations and program service fees.

Immigration Counselors provide support and assistance to individuals and families facing adjustment challenges as well as assisting and resolving problems related to immigration and naturalization, legal assistance, citizen outreach program, cross-cultural counseling advocacy and employment counseling. Accredited by the U.S. Department of Justice, our counselors are BIA certified to represent individuals in Immigration Court. An Employment Counselor assists legal immigrants to enhance their employability and to find jobs. In 2011, the Immigration Counseling Department assisted 3,933 clients, many of whom were families trying to get reunited with loved ones or individuals seeking U.S. citizenship. These programs and services are funded through HUD, United Way, fees for services and individual donations.
