The Sisters of Charity Foundation of Canton is a ministry of the Sisters of Charity of St. Augustine, and is based upon the gospel values, Catholic social teaching, and the charitable mission of the Sisters and the Roman Catholic Church. The Foundation's focus is to address the needs of the poor and underserved by understanding the root cause of poverty, nurturing the growth of healthy communities emphasizing youth and family and measuring the outcomes of these efforts.

Since 2001 the Prescription Assistance Network of Stark County works with the funders, social service agencies and health care providers to help the uninsured, underinsured, and Medicaid / Medicare population in Stark County obtain needed medications. The program has achieved more than \$3 million in savings by identifying free or discounted drugs for people in need.

A long term initiative to improve early education and child care in Stark County has helped to increase the number of centers and preschools nationally accredited or recognized by Ohio's quality improvement rating system, Step up to Quality. This initiative focuses significant resources on professional development and support of early childhood professionals and caregivers of young children. In collaboration with community partners, the foundation has supported a public awareness campaign targeting parents of young children to educate them on the importance of the early years.

The Bethlehem Project for oral health improves access to dental care services for low income children and their families via home visitations and case management to at-risk children up to three years of age.

The Sisters of Charity Foundation of Canton begins its grant award process by reviewing grant proposals to ensure the Foundation guidelines are met for mission, geographic area, program area, and population served. Required documents from potential grantees include audited financial statements, IRS Determination Letter and IRS Form 990. After the initial verification has taken place, a Program Officer / Grant Manager is assigned to each proposal. Additionally, site visits are conducted with representatives from the organization, and a narrative summary is completed for the Distribution/Grant Committee.

All proposals are then carefully reviewed by the staff and Distribution/Grant Committee to identify those applications that best serve the Foundation's mission, and to analyze proposed budgets to fulfill our obligations as stewards of Foundation funds. After the selection process is complete, the distribution committee makes its recommendations to the full Board of Directors at its next meeting.

After a grant is awarded, grants are monitored through site visits to ensure proper use of funds. Periodic reports and budgetary information are required and are reviewed for consistency and adherence to program goals and objectives.

When the grant period has ended, closed grant/final evaluation reports are completed and reviewed by Program Officer/Grant Manager for compliance with the grant agreement and used as an internal document to inform future funding. Grant files are archived electronically for future reference.
