College scholarships: High school seniors of our consumer/members fill out a provided application to apply for the scholarship. Applicants are then interviewed by a team that includes management of Midwest Electric and Wright State University staff members. Of the applications received (this past year around fifty), only seven applicants can receive a scholarship. Checks are made out directly to the award recipient.

Energy-efficient home rebate: Only future home owners of new construction that will be served by Midwest Electric may apply for this rebate. The contact Midwest with their intent and

Midwest staff review the rebate parameters with the future homeowner. To receive the rebate, the newly built home must pass an energy audit conducted by an independent rating

agency. The new home must have energy-star rated windows and appliances. The home must have pre-determined levels of insulation, meet certain heat-loss standards, and pass

a minimum threshold on a "blower-door" test. Once these tests have been passed, we issue the rebate to the homeowner.

Energy audit rebate: Midwest Electric members who wish to have a commercial or home energy audit performed will contact the office. Midwest will have an independent energy auditor

meet with the homeowner (or business owner) and conduct an audit of their home (or business) and provide the homeowner with a report that identifies ways (and expected payback)

to address energy losses and lower their energy bill. Midwest Electric will pay one-half of the standard audit fee. In 2011, two members that were selected due to high usage curves

and had household incomes lower than a certain threshold received a more robust energy audit that was reimbursed by the power supplier, Buckeye Power Inc.

In-Home Appliance - rebate program: Cooperative members were invited from June 15, 2011 through October 15, 2011 to have major appliances upgraded that consume large amounts

of electricity. Eligible appliances included water heaters, geothermal systems, and dual fuel heating systems. To receive the rebate, the appliance had to be installed in the above

noted time-frame but also had to permit a load control device to be wired into the appliance electrical supply. The cooperative's power supplier, Buckeye Power, would then cycle

through load control devices whenever their power peak was coincidental with the regional transmission operator's annual peak. The program is designed to help the homeowner

lower their energy consumption with modern appliances and help the cooperative to lower its' contribution to critical peak pricing by reducing some of the coincidental peaks, we

were able to pass that savings back to the member through a pass-through power cost adjustment rate rider. Each qualified appliance received either a \$100 rebate or a \$200 rebate

and some consumers were able to qualify for multiple rebates.

Tree seedling program: All Midwest Electric members are invited to submit tree seedling invoice reimbursements for newly planted trees. Each member is limited to a \$15 reimbursement.

990 Core, Page 6, Part VI, Section B, Item 11b: At a monthly board meeting prior to filing the Form 990, a preliminary copy of the 990 was reviewed by all board members, the general manager, the manager of finance, and the corporate attorney. After reviewing all pages of the core form and all required schedules (outside of Schedule O) of the 990, all present were asked if they had any questions or disagreements with the proposed filing. No amendments were suggested. After this initial review, a digital copy of Schedule O was made available for review by each board member and key employee.

990 Core, Page 6, Part VI, Section B, Item 12c: Annually, the board members and key employees are required to complete a conflict of interest and disclosure questionnaire. Based upon the results of that questionnaire, any reported conflicts with third parties or internal parties are identified and may affect the board member's status. If a conflict is small, the board member must recuse himself from decisions involved with that entity/person. If the conflict is substantial or prohibitive based upon the Code of Regulations, the board member would be subject to removal as detailed in Article VI of the Code of Regulations.

990 Core, Page 6, Part VI, Section B, Item 15: Annually, the board pays for an independent consultant to perform a wage and salary comparison of cooperative wages against those of local, state, and national businesses of like-kind size. The compensation goal of the board is to set pay within a standard deviation of the average wage paid for that position in these similar-sized organizations. The CEO will then use the same wage study and techniques to set the individual wages for management personnel of the cooperative. The board will then have an executive session to discuss and arrive at the general manager's salary for the upcoming year.

990 Core, Page 7, Part VII, Section A, Item 1a, Column E: Prior to the 990 completion, each board member, officer, and key employee was given an information-gathering questionnaire to complete. The questionnaire explained reportable conditions and gave the IRS' definition on key terms. Upon receipt of all eleven questionnaires, they were reviewed to identify any reportable situation. Additionally, if any reportable situation was known or observed by another governing member, they were expressed with necessity to come forward with that information.

990 Core, Page 10, Part IX, Line 4: In adhering to IRS instruction, patronage capital retired to active and former members for the calendar year are reported on this line. Conceptually, patronage represents a member's ownership in a cooperative and any retirement of patronage is, in fact, a return of that investment and not a traditional expense as viewed in standard accounting rules. By including this amount on the statement of functional expenses, we have overstated our current year's expense by \$1,335,317 and we had to create a balancing adjustment on Line 24d to properly adjust our expenses back to GAAP and USDA accounting methodology.

990 Core, Page 10, Part IX, Line 24d: In adhering to the IRS instructions for expense disclosures on Part IX, Statement of Functional Expenses, items that are not treated as current year expenses on our audited statements have been overstated on this tax return. For instance, large portions of labor, labor overhead, and subcontracted labor are capitalized in the cooperative's fixed assets in accordance with USDA accounting procedures. These assets have a multi-year life and are either depreciated or amortized over their useful life. By reporting our gross payrolls in lines 7, 8, 9, and 10, we need to recognize an offsetting amount in line 24d to properly adjust our reported Total Functional Expenses to a more accurate number. In addition, as stated above in Line 4, the retirement of patronage is not viewed as a traditional expense but rather a return of invested capital. The entire amount on line 4 (\$1,335,317) is not considered an expense for GAAP or USDA standards and by overstating this amount on Line 4, we need to create an offset amount on line 24d to successfully adjust our Total Functionalized Expenses back to the audited balance of \$25,828,978.
