Cancer Services provides direct services to people with cancer and their families living in northeast Indiana including practical help with tangible resources and emotional support. Practical help in 2011 included \$124,432 financial assistance to help with cancer-related medical costs, 448 incidences of transportation assistance, 947 items of medical equipment loaned, 885 wigs provided and more than 40,000 items of personal health supplies such as bandages. Professional staff also provides information, referral and personalized advocacy regarding cancer and insurance, employment and financial matters.

Professional staff and volunteers provide emotional support through support groups as well as one-to-one counseling. Cancer Services Advocates made more than 600 visits to homes, hospitals and treatment centers and served more than 2,400 local people with cancer and their families.

Education services are also provided to people with cancer and their families, medical professionals and interested community members. In 2011, Cancer Services hosted an Educational Symposium titled Cancer and the Law/Understanding Health Care Reform attended by 47 people. Registered Dietitians presented four nutrition seminars and various programs provided information related to cancer and wellness. Additionally, a lending library of resource materials is maintained and volunteers staffed more than 37 health fairs in 2011 in workplaces and other community sites.
