The Taxpayer provides a variety of topical areas in which young people can participate in and develop leadership skills. These skills are developed through hands on experience by allowing young adults to become leaders of their groups. As part of this effort, 14 workshops were available to members, ranging from animal and entymology to engineering and youth leadership. Also, 16 last-year members participated in the Honor Group, which completed a service project benefiting the Johnson County Fair grounds. The 2011 project involved the group remodeling one set of restrooms at the fairgrounds. The 4H club also organized an ambassador program, whereby 39 of its student-members visited area grade schools and talked to nearly 6,000 3rd, 4th and 5th graders regarding the benefits of becoming a 4H member. As part of its nurturing of young students, 40 of its youngest members attended a 3 day summer camp, which was partly staffed by 9 Junior Leaders. In addition, a 2 day mini-camp for more than 50 young members was held at the fairgrounds, with junior leaders serving as counselors under adult member supervision. Finally, the Taxpayer supported over a 1,000 local young people who participated in projects judged at the local fair.
