We are pleased to confirm our understanding of the services we are to provide for National Niemann-Pick Disease Foundation, Inc. for the period ended December 31, 2011.

We will audit the statement of financial position of National Niemann-Pick Disease Foundation, Inc. as of December 31, 2011 and the related statements of activities, and cash flows for the period ended December 31, 2011. We will also prepare the Organization's federal tax form 990 and Wisconsin state information return for the period ended December 31, 2011.

Audit Objectives

The objective of our audit is the expression of an opinion as to whether your financial statements are fairly presented, in all material respects, in conformity with U.S. generally accepted accounting principles. Our audit will be conducted in accordance with generally accepted auditing standards established by the Auditing Standards Board (United States) and will include tests of your accounting records and other procedures we consider necessary to enable us to express such an opinion. If our opinion is other than unqualified, we will discuss the reasons with you in advance. If, for any reason, we are unable to complete the audit or are unable to form or have not formed an opinion, we may decline to express an opinion or to issue a report as a result of this engagement.

Audit Procedures
