The 2011 audited financial statements include the following note regarding the restatements. "During 2011, the Foundation discovered errors in the prior year reporting of deferred rent receivable, net assets, and contribution revenue. A \$100,000 permanently restricted pledge that was made in 2008 was not recorded until 2010 when the cash was received. This should have been recognized in 2008 when the pledge was made. In addition, the Foundation determined that deferred rent receivable was not recorded in 2009 and 2010 to recognize rent revenue on a straight line basis in accordance with GAAPUSA. Lastly, the Foundation determined that they had included funds designated by the Board for scholarships in the temporarily restricted and permanently restricted categories."
