The People's Harm Reduction Alliance (PHRA) operates a syringe exchange program in Seattle's University District. Through this program, PHRA provides injection drug users with the resources they need to avoid HIV and Hepatitis C infection, prevent death and lead healthier lives. Specifically, PHRA provides injection drug users with sterile syringes, education related to safer drug use practices, referrals to drug treatment and Naloxone, a lifesaving medication that can reverse opiate overdose. In 2011, 1.9 million sterile syringes were distributed through the needle exchange program, including 900,000 exchanged at the fixed site in the University District.

In addition to the fixed-site syringe exchange program in Seattle's University District, PHRA also operates a mobile syringe exchange that delivers safer injection drug use supplies to suburban and rural regions of King County. This second syringe exchange program ensures that all King County residents, no matter where they live, have meaningful access to sterile syringes. PHRA's mobile exchange distributed roughly 1,000,000 syringes in 2011.

The People's Harm Reduction Alliance provides free and confidential Hepatitis C testing to communities at high risk of infection. We believe that knowing one's Hepatitis C status allows individuals to make safe and healthy decisions that ultimately improve the wellbeing of the community.
