Annual conference including practitioners and researchers from a variety of disciplines, including health and human service providers, academics and researchers. 260 attendees participated in a keynote address by Leslie Grant, Ph.D, 11 poster and exchange sessions, and 14 break-out sessions, led by experts from throughout the State. Scholarships were presented to two students studying for professional work in the aging field. In an effort to identify role models working in the aging field, an award was presented to the Gerontologist of the Year. This conference allows practitioners, researchers, faculty and students to gain information on evidenced-based services to seniors, to learn about relevant research that improve results, and to highlight new services that meet emerging and critical issues, such as elder abuse. Attendees receive continuing education credits for their participation in the conference.

Education is a primary focus of MGS. 6 webinars were held on topics such as: demographics and trends in aging population, end of life issues, caregiving, care management, sex and aging, and compassion fatigue. Presenters were experts from Minnesota (including: Tom Gillaspay, MN Demographer, Dr. Robert Kane, Dr. Joseph Gaugler. Feedback from participants indicated that the information and resources in the webinars was used to improve services, and to train volunteers and staff about the issues involved in providing effective services for older adults. Over 200 people attended the webinars and received continuing education credits. In addition, information was shared through a bi-monthly newsletter, email alerts and on the MGS website at [www.mngero.org](http://www.mngero.org).
