Koinonia House of DuPage County, Inc., d/b/a Koinonia House of Wheaton (KHW)

Provide a Christian family home-based discipleship program (lasting about 15 months) for men recently released from prison. KHW can work with up to four residents at one time. In FY2011, three men were direct beneficiaries of this discipleship program. Indirect beneficiaries include family members with whom the men are reconciling and rebuilding relationships. Other indirect beneficiaries include the members of the three mentoring churches who provided discipleship, friendship and ministry opportunities to the KHW residents.

In-Prison Ministries

Educate, motivate and minister to incarcerated persons to prepare them for potential release into society. In addition, mentor Christian inmates through services, visits and correspondence. FY2011 highlights include services in prisons and jails in IL, LA, MN, NC, TN and VA. In December, we introduced a new weekend event called "Freedom God's Way: From Prison to the Promised Land through Revived Hearts and Reformed Minds." It was very well received by the men in Lino Lakes Correctional Center in MN.

Meet Me at the Gate (MMATG)

Train and equip the Church to minister to Christians coming out of prison; identify and train individuals interested in establishing post-prison ministries of their own, work with local, state, and federal officials and persons within the Department of Corrections to facilitate prison reform; educate the general public concerning the need for post-prison ministry; mentor and encourage those recently released from prison. FY2011 highlights include the weekly dinner and Bible study held at the KHW for those transitioning back to society; counseling 4 young men at the DuPage County Jail and their families upon their release; working with Willow Creek Church of DuPage in mentoring a woman released from the county jail; conducting a MMATG seminar for a church in Taylor, MO.
