Damasis - until two and one half months from the posting of said demand. The initial IRS letter was sent to the official Ateitis Relief Fund address at 1380 Castlewood Dr. in Lemont, IL 60439. Unfortunately, our Board of Directors only meets at that address two to three times annually and the caretaker of the facility did not notify the executive director that our rarely active mailbox had an IRS letter.

As the person who has the dubious responsibility of completing the annual filing with IRS, I apologize for the oversight of failing to include schedule A for 2011. An oversight that is particularly nagging given that I included said schedule in the 2010 990 submission.

Our Board consists of volunteers - primarily retirees - who dole out grants of relatively small amounts to religious youth groups. We have avoided hiring a tax accountant to reduce expenses in a time period when our fund-raising has been under substantial economic pressure.

We respectfully request IRS to rescind the penalty of \$3200.00 charged for our oversight. Hopefully, we can avoid that difficulty in the future. To improve the communication between Ateitis Relief Fund and the IRS, please send any further information and requests to

Petras Kislellius who is listed as President of the Fund passed away a few years ago.


