THE SOUTH CAROLINA CENTER FOR FATHERS AND FAMILIES (CENTER) WAS ESTABLISHED IN 2002 AS A MINISTRY OF THE SISTERS OF CHARITY OF ST. AUGUSTINE. THE FATHERHOOD INITIATIVE OF THE SISTERS OF CHARITY FOUNDATION OF SOUTH CAROLINA (FOUNDATION) LED TO THE ESTABLISHMENT OF SIX FATHERHOOD ORGANIZATIONS. THE CENTER THROUGH A PARTNERSHIP WITH THE FOUNDATION AND THE SOUTH CAROLINA DEPARTMENT OF SOCIAL SERVICES, PROVIDES FINANCIAL SUPPORT FOR THESE PROGRAMS. ADDITIONALLY, THE U.S. DEPARTMENT OF HEALTH AND HUMAN SERVICES ADMINISTRATION FOR CHILDREN AND FAMILIES PROVIDED A GRANT TO SUPPORT RESPONSIBLE FATHERHOOD PROGRAMMING. THE COMMUNITY-BASED PROGRAMS PROVIDE SERVICES TO LOW-INCOME FATHERS AROUND RESPONSIBLE FATHERHOOD, JOB READINESS AND EMPLOYMENT, PARENTING AND CO-PARENTING, HEALTHY RELATIONSHIPS, AND ADDITIONAL SERVICES ON A CASE BY CASE BASIS. TO DATE THE CENTER HAS SERVED 8,667 FATHERS AND FAMILIES AND HAS IMPACTED THE LIVES OF 15,917 CHILDREN.
