28 In a short six months in 2011 Valhalla Project moved into a 200-acre tract with a 34 year-old neglected house and immediately began work to make the property and house suitable and welcoming for Soldiers. Some of the major projects on the house were overall cleaning and de-junking, expanding doors for wheelchair access, rebuilding a dangerous "sunken" living room, converting a rec room into a bunkhouse complete with handicap accessible bath, building bed frames from rough-cut cedar lumber, painting, and general fixing up outside, we constructed sixteen 8' x 4' raised bed gardens for vegetables and fruit, planted a small orchard and berry patch, raked and composted several years worth of fallen leaves, patched leaking gutters, installed a preliminary rainwater collection system for the garden, cut and stacked firewood, picked up bags full of trash, removed crowded or dead trees, had the area treated for noxious insects, and acquired Guinea fowl as a primary tick control measure and for general entertainment. We began to educate the regional community and general public through news articles and TV reports, welcomed volunteers who were interested in assisting, and maintained an Internet web site and Facebook page to keep everyone informed of progress. During this period we had our first Soldier visits and heartily welcomed their contributions to Valhalla Project.
