IT WAS RECORDED AS A REDUCTION TO TRUST CORPUS. THE ROBERT AUGUST KORANDA MEMORIAL FOUNDATION, FEIN 36-7417497, RECORDED IT AS A TRANSFER IN TO CORPUS AND NOT A CONTRIBUTION.
