THE SEMINARS FEATURE SPEAKERS THAT FOCUS ON VARIOUS WATER ENVIRONMENT ISSUES. APPROXIMATELY 708 MEMBERS ATTENDED THE SEMINARS AND 158 MEMBERS ATTENDED THE WORKSHOPS. SINCE THE ASSOCIATION IS A STATE-WIDE ORGANIZATION, THERE ARE LOCAL SECTIONS OF THE ASSOCIATION THAT CONDUCT ACTIVITIES RELATED TO WATER ENVIRONMENT ISSUES IN THE LOCAL AREA ALSO.
