	EDUCATION Programs provided by the Brain Injury Association of Michigan included an annual two-day conference with an unduplicated count of 1,416 with brain injuries, their family members, professionals in the field of brain injury, insurance and medical professionals Over \$4,161 in reduced registration fees were provided to 51 persons with brain injuries and/or their family members attending the conference The fourth annual specialty conference "Complementary and Alternative Medicine Conference" to address evidence based complementary and alternative treatments to benefit those with a neurological condition 106 attendees were registered, 7 attendees received financial assistance and 15 exhibitors participated Members and the general public were able to utilize the Association's library and resource room, which contains thousands of articles, books and videos Brain Injury Association of Michigan materials were distributed at over 109 community events and professional meetings ACBIS In 2011, 137 professionals applied to become Certified Brain Injury Specialists Since the inception of this program in 2003, Michigan has consistently maintained the lead in the total number of CBIS' nationwide at 18% (941 Michigan certificants) GRANTS Ten educational scholarship grants of \$ 1,000 each were awarded to graduating high school seniors pursuing a career in either health care or rehabilitation fields This program is the result of the support of Special Tree Rehabilitation Systems

	SUPPORT SERVICES FOR INDIVIDUALS WITH A BRAIN INJURY AND VETERANS, CHAPTER SUPPORT1)In conjunction with the Brain Injury Association of America, BIAMI continued its partnership as one of the National Brain Injury Information Centers (NBIIIC) in 2011 A single nation-wide toll-free number routes calls made in Michigan directly to BIAMI staff BIAMI staff also serves as a regional hub for this system during times when national staff is unable to handle calls 2)Support Programs include 19 chapters and support groups throughout Michigan which meet monthly with over 300 people attending each month Staff responded to over 3,500 calls on the toll free telephone line requiring over 2,000 hours of support Individualized packets of information were sent to assist families and persons with brain injuries In 2011 the use of social media continued to be used more extensively and as a result it created many additional inquiries BIAMI uses Facebook, Twitter, and U-Tube with over 1,844 followers by the end of 2011 In addition, our enhanced website with 44,234 visits and in excess of 112,000 pages viewed has broadened our communication with members and the general public When searching on Google for "brain injury association," our Association ranked second 3)The Survivors' Committee met periodically and organized recreational activities In the spring, a shopping "Spring Fling" weekend was held for 78 persons with brain injuries and their family members During the annual conference, the Committee planned, organized and conducted a dinner and dance for 150 members The cost of this event was \$3,591 and was sponsored by the Association 4)During 2011, BIAMI hired a new TBI Ombudsman, this Program continued as a result of the funding through the State of Michigan's Department of Community Health's TBI Grant The Ombudsman fielded 32 calls Issues addressed residential programming, special education assistance, support groups, Long Term Care Ombudsman, Social Services, The Ombudsman sent our 62 letters of Introduction to CIL's, LTC Ombudsman, Area Agency on Aging, Special Ed Directors and disability advocates Provided 3 presentations to Michigan Rehabilitation Services staff and Department of Human Services Foster Care staff Upon request partnered with Region 2 AAA ADRC (Aging Disability Resource Center), MDDC Education and Advocacy group and Family2Family Educational Workgroup 5)During 2011, the Veterans Program continued as a result of the funding through the State of Michigan's Department of Community Health's TBI Grant This year, the Veterans Program staff conducted 148 awareness, advocacy and training presentation activities to a total audience in excess of 17,000 The average audience of 115 per event remains about the same as previous years The program also conducted 11 Veteran recreation events for more than 700 troops which have proven to be an exceptional mechanism for them to relax with other Veterans and absorb the "Invisible Wounds" message delivered at critical junctures of each activity While a wonderful way to say "Thank you" to our troops, these activities remain the single most effective way to keep the message front and center In 2011, the program hosted its first Annual Veterans TBI Summit which was attended by 85 participants from the VA, DoD and private sector providers as well as numerous TBI combat injured Veterans and their spouses They also conducted 28 live radio interviews out of Lansing, Midland, Saginaw, and Flint areas The Veteran Program staff also provided testimony to both the House Military and Veterans Affairs Committee and the House Insurance Committee on the potential impact of TBI healthcare issues in the state
