The Cronin Foundation may initiate projects on its own as well as assisting other organizations and groups in the financing of a limited number of projects and/or grant requests directed at the enrichment of the Marshall community.

The Board of Trustees reviews requests quarterly following application deadlines of September 1, December 1, March 1 and June 1, or at such other meetings as it may call from time to time for a specified purpose or grant review.

Following is major criteria which it will use in evaluating requests:

1. Grants shall include projects which shall enrich, economically, socially, environmentally or in healthiness, substantial numbers of persons residing in the Marshall School District.
2. Grants will be made primarily to organizations having tax-exempt recognition under Section 501(c)(3) of the Internal Revenue Code and to these organizations described in Section 509(a)(1) or (2) of the IRS Code of 1954 as amended, educational institutions, municipal corporations, and ecclesiastical organizations.

3. The Foundation makes no grants directly to individuals.

The Foundation does not make grants or loans directly to students for general scholarships for high school, undergraduate, or graduate studies, but may grant funds to an organization which will benefit categories of students in either manner.

4. Grant commitments will usually be limited to one year or one project. Further funding may require an additional grant application or report stating progress achieved since funding of the initial grant.
5. Grant recipients may be required to provide the Foundation with both a periodic and a final report of the activities accomplished under the grant and a full financial statement describing expenditures.

APPLICATION PROCEDURE

To be considered, your application should include the following information and may include any other information which the applicant believes helpful.

1. Name, address and telephone number of the organization or project and the name, address and phone of the person who is the point of contact for the project and/or program.
2. Who is responsible for carrying out the project? How will execution of the project be supervised? Who will be the project contract person?
3. Is the organization carrying out the project and/or program a qualified 509(a)(1) or (2), an educational institution, municipal corporation, or ecclesiastical organization?
4. Has the organization secured tax-exempt status under Section 501(c)(3) of the IRS Code? If so, include a copy of the IRS determination letter. Local units of recognized national non-profit organizations will not be required to submit the letter.
5. Describe the project and/or program.
 - a. WHAT are its objectives?
 - b. HOW will it benefit persons living primarily in the Marshall School District?
 - c. WHERE will it be carried out?
 - d. HOW will it be carried out?
 - e. WHEN will it be carried out?

6. Are there similar projects? What distinguishes this project and/or program from others in the same general field? Does this project have unique characteristics?
7. What is the proposed budget for the project and/or program?
8. How much money is being requested from the Cronin Foundation?
9. Will the project require additional funding to sustain it? How would sustaining funds be raised if required?
10. Have funds been requested from other sources? If so, in what amounts? Have any other funds been received? If so, from whom and amounts received from each. If turned down, do you have alternate plans for raising funds? If so, what have you considered doing?
11. If the applicant is a presently active organization, the last three years' financial statements. In the event the applicant is a new organization, a current balance sheet and proposed budget should be submitted.
