TFDP exists for the purpose of improving the defense of human and civil rights secured by law and, more particularly, the fairness and accuracy of the criminal justice system in Texas. TFDP focuses primarily on improving access to counsel and the quality of representation provided to low- and moderate-income residents. TFDP defends the rights of indigent criminal defendants through litigation, education, and advocacy.

TFDP pursues civil litigation in situations where it believes the indigent defense practices of a Texas county violate the U.S. Constitution and/or state law, and represents a very limited number of indigent criminal defendants in appellate and/or habeas corpus proceedings that raise significant issues involving the rights of low- and moderate-income people accused of criminal offenses. TFDP also prepares and files amicus briefs in the same categories of cases in which it engages in direct litigation. The objective of this program area is to improve the criminal justice system and protect the rights of indigent criminal defendants by increasing the level of governmental compliance with legal requirements regarding the right to counsel. Although TFDP is only able to litigate a small number of cases each year, cases brought by TFDP establish legal precedents that benefit all indigent defendants in Texas. A list of cases in litigation in 2011 is provided in Schedule O.

4b (Code:) (Expenses \$ 60,000 including grants of \$ 0) (Revenue \$ 0)
TFDP provides technical assistance to local officials and participates in stakeholder working groups convened by judicial branch agencies, bar associations, and other agencies in order to identify best practices for the delivery of indigent defense services. The objective of this program area is to improve the delivery of indigent defense services through the development of model procedures and new local programs. In 2011, TFDP helped develop state bar practice guidelines for criminal defense representation, secure approval of those guidelines by the State Bar Board of Directors, and educate defense attorneys and judges about the guidelines' content. TFDP helped establish new amnesty and indigency programs for the Texas Driver Responsibility program that were implemented in 2011. TFDP also researched and drafted judicial educational materials concerning limitations on judges' ability to order defendants to repay appointed counsel fees, and that outline the steps and findings required before a repayment order may be issued. These judicial education materials were adopted and published by the Texas Indigent Defense Commission.

TFDP monitors Texas's indigent defense system and uses research generated by this activity to develop timely information for dissemination to the public and to build support for criminal justice reform. TFDP also researches national indigent defense practices and standards for their potential implementation in Texas. The objective of this program area is to raise public awareness of indigent defense practices and to promote solutions to systemic problems through improved research and increased access to reliable data.

Part III, Line 4a: The following cases were in litigation in 2011

Heckman v. Williamson County: In a state civil rights action, TFDP represents a proposed class of indigent misdemeanor defendants who are challenging policies and procedures used to deny defendants access to counsel. The challenged practices affect thousands of defendants charged with low-level offenses each year. TFDP is seeking equitable relief that will end the challenged practices. TFDP is seeking fees in this case, with the amount to be determined at the time of resolution.

Asberry v. State: TFDP filed an amicus brief before the Texas Court of Criminal Appeals in support of a defendant's claim that he was improperly denied a court-appointed investigator and expert in his criminal case. The court granted review on the question of whether an indigent defendant must present an affidavit from an expert to support a request for a court-appointed investigator or expert. In its brief, TFDP argued that an affidavit is not necessary. The court ruled that a request for assistance does not need to be supported by an expert affidavit. The outcome of this case will affect the standard that every indigent defendant must meet in order to obtain the expert and investigative assistance necessary to prepare an adequate defense. TFDP did not seek fees in this case.

Lilly v. State: TFDP filed an amicus brief before the Texas Court of Criminal Appeals in support of a defendant's claim that his right to public court proceedings was violated. In its brief, TFDP argued that the trial court failed to meet the strict standard for court closure set forth in federal case law. The court adopted the federal standard and ruled that the trial court failed to meet that standard. The outcome of this case will benefit tens of thousands of criminal defendants who plead guilty each year in court proceedings that are closed in violation of the federal standard that has now adopted by the Court of Criminal Appeals. TFDP did not seek fees in this case.

State v. Balentine. TFDP represents an individual on a motion to rescind a clerk's bill of costs that required the individual to pay over \$100,000 in reimbursement for the cost of providing court-appointed counsel in a criminal case in which the individual was sentenced to death. The bill of costs was issued 11 years after the defendant was sentenced and without a judicial finding that the defendant had the ability to pay the assessed amount. The bill of costs was rescinded on TFDP's motion. TFDP continues to seek repayment of the inmate trust funds that were garnished before the order was rescinded. TFDP is not seeking fees in this case.

Direct Case Assistance (Expenses \$30,000): TFDP provides non-litigation assistance to approximately 350 indigent defendants each year.

This assistance includes helping indigent defendants request and obtain appointed counsel.

The Executive Director also monitors members' compliance with the conflict of interest policy on an ongoing basis

Part VI, Line 15a: Before setting the Executive Director's starting salary, TFDP's governing body obtained salary information from other nonprofit law firms to ensure comparability. Individuals who were at the time non-voting members of the governing body and who were employed at similar organizations also affirmed that the salary was comparable. The governing body's deliberation on and decision regarding this matter were contemporaneously recorded in the minutes of the formal meeting at which they took place. The governing body has continued to consider comparability information, as well as performance and cost of living adjustments, when setting subsequent salary increases. Those deliberations also are recorded in meeting minutes.

Part VI, Line 15b: TFDP does not have any officers other than the Executive Director, whose compensation is addressed on Line 15a. TFDP does not have any key employees.

Part VI, Line 19: TFDP makes its governing documents and conflict of interest policy available for public inspection upon request. TFDP does not make its financial statements available for public inspection. TFDP makes its financial information available through public inspection of the financial information included in its Form 990.
