Environmental Health Program: In 2011 we educated the public about the health hazards associated with bisphenol A (BPA) and supported and won a broad phase-out of BPA from all reusable food and beverage containers sold in Maine. We educated the public about the Kid Safe Products Act intent, accomplishments, statutory deadlines, and requirements. We gathered, analyzed, and made public new data collected by Maine's Department of Environmental Protection about the use of BPA and nonylphenol ethoxylates in over 650 products including toys, house paint, and food packaging. We identified several hundred new supporters of safer chemicals and hosted screenings of the film "Living Downstream" to educate the public about the connections between use of toxic chemicals and cancer. We organized a scientific conference on the connections among chemicals, obesity, and diabetes that attracted over 150 doctors, nurses, public health professionals, and health-affected individuals, and featured leading scientists in the field of obesogen research. We analyzed the Toxic Substance Control Act to identify the needed improvements to protect public health and provided strategic policy advice for the development of the Safe Chemicals Act of 2011. We coordinated the Alliance for a Clean and Healthy Maine, a public health coalition promoting use of safer chemicals in consumer products.

Sustainable Economy Program: In 2011 we made steady progress with the University of Maine on a project to demonstrate that bioplastic polylactic acid can be produced to industry standard from potato processing waste. We organized an annual meeting of the Sustainable Bioplastics Council of Maine that attracted representatives from 20 companies to discuss emerging opportunities in the bio-based plastics market. We generated business and editorial support for investment in research and development bonds for clean technology based on sustainable use of Maine's natural resources. We also pursued cooperative agreements with companies to bring fermentation technologies to Maine to produce lactic acid from wood-derived sugars.
