THE MEMBERSHIP PROGRAM IS THE LIFE BLOOD OF THE SOCIETY. IT ENCOMPASSES THE GOVERNANCE OF THE SOCIETY IN THE BOARD OF DIRECTORS AND THE ANNUAL HOUSE OF DELEGATES. THE SOCIETY OFFERS EDUCATIONS PROGRAM, PROCESS IMPROVEMENT AND CONTINUED MEDICAL EDUCATION CREDITS. IT WORKS IN STRONG ALLIANCE WITH ITS COUNTY MEDICAL SOCIETIES AND MAINTAINS AN ACTIVE PRESENCE IN THE AMERICAN MEDICAL ASSOCIATION. THE ADVOCACY IS THE NEXT LARGEST PROGRAM AREA. THE SOCIETY HAS A STRONG VOICE AT THE STATE CAPITOL AS WELL AS IN WASHINGTON, D.C. STAFF TRAVEL THE STATE TO LISTEN TO THE DOCTORS' CONCERNS. THE SOCIETY ALSO TAKES DOCTOR LEADERSHIP TO WASHINGTON TO MEET WITH WISCONSIN'S REPRESENTATIVES FACE TO FACE, TO DISCUSS IMPORTANT LEGISLATIVE ISSUES AFFECTING THE HEALTH OF WISCONSIN. A POLITICAL ACTION COMMITTEE AND CONDUIT ARE MAINTAINED TO OFFER SUPPORT TO LEGISLATIVE CAMPAIGNS TO HELP FIGHT FOR THE SOCIETY'S CONCERNS. STRATEGIC PROJECTS COVER AREAS OF HEALTH ACCESS AND COVERAGE TO QUALITY IMPROVEMENT PRACTICES TO IMPROVING PROFESSIONALISM IN THE WORKPLACE. THE QUALITY EFFORTS ALONG WITH DRCONNECTION, A WEBSITE OF DOCTORS' PUBLIC INFORMATION, ARE THE LARGEST COMPONENTS IN THE GROUP. THE PUSH BEHIND STRATEGIC PROJECTS IS TO CREATE VALUE AS WELL AS NON-DUES REVENUES FOR THE SOCIETY.
