A PRIMARY FOCUS IS ON DEALING WITH LANGUAGE AND CULTURAL BARRIERS TO MEET CLIENTS' BASIC NEEDS. INFORMATION AND REFERRALS, ASSISTANCE WITH LEGAL AND IMMIGRATION PAPERWORK, AND CASE MANAGEMENT HELP CLIENTS INTERACT WITH NEW SYSTEMS THAT MAY BE CONFUSING TO THEM. THE IOP SERVED 702 INDIVIDUALS IN 2011. THE WOMEN'S ECONOMIC EMPOWERMENT CENTER INSPIRES AND EMPOWERS WOMEN OF ALL AGES TO REALIZE THEIR FULL ECONOMIC POTENTIAL IN A COMMUNITY ENVIRONMENT CREATED BY WOMEN FOR WOMEN. A GOAL FOR EACH MEMBER IS IMPROVED OR ACQUIRED EMPLOYMENT TOWARD SELF-SUFFICIENCY AND CAREER ADVANCEMENT. CASE MANAGEMENT, JOB READINESS, MENTORING, DROP-IN SERVICES, AND ADDITIONAL WORKSHOPS ARE ALL AVAILABLE TO THE PUBLIC. IN 2011, THE WOMEN'S ECONOMIC EMPOWERMENT CENTER SERVED 152 WOMEN WHO USED THE CENTER A TOTAL OF 4,065 HOURS.
