COVANTAGE HAS 66,346 MEMBERS, AND FOR THOSE LOOKING TO SAVE, COVANTAGE STRIVES TO PAY DIVIDEND RATES THAT ARE ABOVE MARKET RATES, EVEN IN THESE TOUGH ECONOMIC TIMES. AS OF DECEMBER 31, 2011, COVANTAGE WAS STILL PAYING AN ANNUAL PERCENTAGE RATE OF 0.75% ON REGULAR SHARE ACCOUNTS WHEN MANY OTHER FINANCIALS DROPPED SIGNIFICANTLY AS THE ECONOMIC CONDITIONS CHANGED. OUR MINIMUM BALANCE OF ONLY \$10 WAS STILL MAINTAINED, WHICH HELPED MANY IN TIMES OF HARDSHIP. MEMBERS WERE NOT ONLY ABLE TO RECEIVE THE BENEFIT OF HIGHER THAN AVERAGE RATES DURING THESE TOUGH TIMES, BUT COVANTAGE STILL REWARDED MEMBERS WITH AN ADDITIONAL PATRONAGE PAYMENT AGAIN IN 2011.
