DEPENDING UPON THE NUMBER OF OPEN POSITIONS ON THE BOARD, THERE ARE
GENERALLY 3-5 NEW MEMBERS A YEAR. EACH BOARD MEMBER CAN SERVE UP TO TWO
CONSECUTIVE 3-YEAR TERMS.
