FOOD SECURITY CAC PROVIDES FOOD PROGRAMS TO DANE, JEFFERSON AND WAUKESHA COUNTIES. AS AN EMERGENCY FOOD OPERATOR, CAC RECEIVES AND DISTRIBUTES FOOD TO PANTRIES, HOMELESS SHELTERS, MEAL SITES AND SENIOR CENTERS. CAC PROCURES FOOD FROM TWO FEDERAL FOOD PROGRAMS - THE EMERGENCY FOOD ASSISTANCE PROGRAM (TEFAP) AND FEMA/EMERGENCY FOOD AND SHELTER PROGRAM (EFSP), - AND RECEIVES AND REDISTRIBUTES DONATED FOODS FROM A MYRIAD OF RESOURCES. IN 2011, CAC DELIVERED 2.9 MILLION POUNDS OF FOOD, WHICH BENEFITTED APPROXIMATELY 860,000 INDIVIDUALS AS REPORTED BY PANTRIES AND MEAL SITES. (THIS NUMBER INCLUDES DUPLICATED COUNTS OVER THE COURSE OF THE YEAR.) CAC ALSO PROVIDES COORDINATION AND TECHNICAL ASSISTANCE, AND ACCESS TO FUNDING FOR PURCHASING FOOD HANDLING EQUIPMENT TO THE FOOD PANTRIES AND MEAL SITES IT SERVES. CAC COORDINATES THE 49-MEMBER DANE COUNTY FOOD PANTRY NETWORK, WHICH SUPPORTS AND COORDINATES EFFORTS TO FIGHT HUNGER IN DANE COUNTY. CAC PROVIDES TECHNICAL ASSISTANCE TO AN ADDITIONAL 20 FOOD PANTRIES AND MEAL SITES IN JEFFERSON AND WAUKESHA COUNTIES.

HOUSING SERVICES ARE FOCUSED ON PREVENTION OF HOMELESSNESS AND HELPING LOW-INCOME HOUSEHOLDS TO OBTAIN SAFE, AFFORDABLE HOUSING AND MAINTAINING THEIR HOUSING ON A PERMANENT BASIS. NUMEROUS PERSONS BENEFITTED FROM CAC'S HOUSING SERVICES IN 2011. PART OF THE AGENCY'S HOUSING SERVICES CONSISTS OF TWO HUD FUNDED SUPPORTIVE HOUSING PROGRAMS FOR FORMERLY HOMELESS FAMILIES AND INDIVIDUALS. ONE IS THE TRANSITIONAL HOUSING PROGRAM IN JEFFERSON COUNTY AND THE OTHER IS THE HOME FOR GOOD PERMANENT HOUSING PROGRAM IN DANE COUNTY. CAC ALSO PROVIDES FINANCIAL ASSISTANCE FOR HOUSING EXPENSES TO FAMILIES AT RISK, SECTION 8 HOUSING CHOICE VOUCHERS IN JEFFERSON COUNTY, INFORMATION AND REFERRAL, HOUSING CASE MANAGEMENT AND LANDLORD/TENANT MEDIATION.

CAC SUPPORTS CAC RELIES ON FUNDING FROM THE U.S. DEPARTMENT OF HEALTH AND HUMAN SERVICES' COMMUNITY SERVICES BLOCK GRANT TO PROVIDE PROGRAMS AND SERVICES IN THE ABOVE OUTLINED AREAS, AS WELL AS TO SUPPORT THE AGENCY'S ADMINISTRATION AND VOLUNTEER COORDINATION. THE AGENCY SERVED APPROXIMATELY 12,500 INDIVIDUALS WITH CSBG-FUNDED ACTIVITIES IN 2011.
