THE PERINATAL FOUNDATION IS A SUPPORTING ORGANIZATION OF THE WISCONSIN ASSOCIATION FOR PERINATAL CARE (WAPC). AN UNRESTRICTED EDUCATIONAL GRANT OF NEARLY \$80,000 AS WELL AS A GRANT OF \$80,000 FOR STAFFING TO WAPC SUPPORTS PERINATAL PROGRAMS. SOME OF THE PROGRAMS THAT WERE POSSIBLE WITH THE FOUNDATION'S SUPPORT INCLUDED THE EXPANSION OF PERIDATA NET, FETAL MONITORING LUNCH AND LEARN SESSIONS, UPDATING PUBLICATIONS, ADVANCING PRE- AND INTERCONCEPTION CARE, PUBLISHING AND PROMOTING THE 4TH EDITION OF LABORATORY TESTING DURING PREGNANCY, AND CARE OF WOMEN AND INFANTS AFFECTED BY METHADONE EXPOSURE, TRANSITION CARE FOR INFANTS LEAVING THE NEONATAL INTENSIVE CARE UNIT, ETC.

THE PERINATAL FOUNDATION PROVIDES \$10,000 TO CHILD CARE CENTERS AT THREE WISCONSIN COLLEGES TO ASSIST WITH PAYMENT OF CHILD CARE EXPENSES FOR STUDENTS IN HEALTH-RELATED FIELDS OF STUDY. THE THREE COLLEGES INCLUDE THE UNIVERSITY OF WISCONSIN- MILWAUKEE, UNIVERSITY OF WISCONSIN - EAU CLAIRE, AND MADISON COLLEGE. THE COLLEGES SELECT THE STUDENT BENEFICIARIES.
