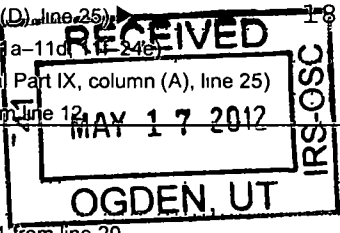

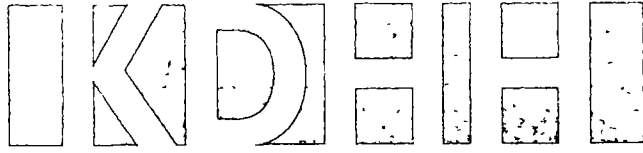

NOTES TO FINANCIAL STATEMENTS

NOTE 1 - ORGANIZATION AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following is a summary of the significant accounting policies affecting the financial statements of The Threshold Foundation, Inc. (the Foundation).

a) Nature of Business

The Foundation was incorporated in the state of Wisconsin in 1989 in order to support The Threshold Incorporated in its goal to provide services to people with disabilities in Southeastern Wisconsin, particularly Washington and surrounding counties. It is the goal of the Foundation to expand on the initial amount contributed by annually receiving contributions from individuals and organizations.

b) Cash

Cash consists of a money market account held, along with investments, by Marshall & Ilsley Trust Company, N.A (M&I Trust Company).

c) Investments

All of the investments of the Foundation are held in trust and managed by the M&I Trust Company. The investments are presented in the financial statements at fair value based on quoted market prices.

d) Income Taxes

The Foundation is a not-for-profit Wisconsin Corporation without capital stock and is exempt from Federal income taxes under Section 501(c)(3) of the Internal Revenue Code, and is not a private foundation.

e) Uncertain Tax Positions

In reviewing its tax positions, the Foundation has concluded that, more likely than not, its tax positions would not result in an unrecognized tax benefit liability. As of December 31, 2011, the Foundation believes that it is reasonably possible the Foundation will continue to have no unrecognized tax benefit liability in the next 12 months. Therefore, no uncertain tax position interest and penalties have been recognized.

The Foundation files tax returns in the U.S. federal jurisdiction and the state of Wisconsin. The Foundation's federal and Wisconsin income tax returns prior to fiscal year 2006 are closed. The Foundation does not have any tax returns currently under examination by a federal or state jurisdiction.

f) Fair Value of Financial Instruments

The carrying amounts of cash, accrued interest and dividends and accounts payable approximate fair value because of their short maturity.

g) Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

h) Revenue and Expense Classifications

The Foundation's revenue sources are contributions received from individuals and organizations, and income from investments. Expenses are classified among program services, management and general, and fundraising based upon the actual purpose of the expenditure.

i) Date of Management Evaluation

The Foundation's management has evaluated subsequent events through February 20, 2012, the date the financial statements were available to be issued.

NOTE 2 - INVESTMENTS

The Foundation's investments and cash are held by M&I Trust Company and managed in accordance with the terms of an investment advisory agreement (see NOTE 3).

The Foundation's investments carried at fair value have been classified, for disclosure purposes, based on a hierarchy defined by the FASB. Fair value for the Foundation's bonds, common stock and pooled equity funds have been determined using quoted prices in active markets (Level 1).

NOTE 3 - FUND FUNCTIONING AS AN ENDOWMENT

It is the intent of the Foundation's board of directors that the net assets of the organization be invested to provide income for The Threshold Incorporated for a long but unspecified period. In this regard, the Foundation's investment fund held in trust by M&I Trust Company functions as an endowment. As required by GAAP, the following is additional information about the fund functioning as an endowment:

Net asset classification, composition and changes in composition

All of the Foundation's net assets are unrestricted, composed of contributions from individuals and organizations without specific donor-imposed purpose beyond the knowledge that the Foundation supports The Threshold Incorporated. There have been no changes in this composition. All of the assets, liabilities, net assets and activities information contained in these financial statements and accompanying notes relate to the fund functioning as an endowment.

NOTE 3 - FUND FUNCTIONING AS AN ENDOWMENT (CONTINUED)

Spending policy and related investment policies

The Foundation has a formally adopted policy for distributions to The Threshold Incorporated. As needed by The Threshold Incorporated, 4% of the total asset balance averaged for the prior five year end totals of the Foundation may be distributed to The Threshold Incorporated. For the years ended December 31, 2011 and 2010, the Foundation distributed \$110,906 and \$111,874, respectively, to The Threshold Incorporated for the support of its program services.

Investment advisory agreements with M&I Trust Company cover the Foundation's investment policies. The investment policies in effect for the years ended December 31, 2011 and 2010 both had return objectives and risk parameters that sought income and growth of capital. The related investment portfolio mix designed around the Foundation's return/risk strategy seeks to maintain 50–70% equity investments, 30–50% fixed income investments, 0-10% alternative investments, and 0–10% cash and cash equivalents. In addition, certain return objectives have guidelines for specific fund-type allocations within equity investments. The Foundation believes that these investment policies, together with additional gifts, will allow it to continue indefinitely its spending policy as described above.
