Notes to Financial Statements

Note 1 Summary of Significant Accounting Policies

Principal Business Activity

Education Foundation of Hudson, Inc. (the "Foundation") is a not-for-profit organization that operates to support and improve the learning opportunities for students in the Hudson, Wisconsin, area by awarding grants and scholarships to students and various school programs. Grants and awards are determined annually by the Board at their discretion in accordance with the Foundation's bylaws. The Foundation's main source of revenue and support is through contributions from the public.

Basis of Accounting

The financial statements are prepared on the basis of cash receipts and disbursements. Consequently, certain revenues and related assets are recognized when received rather than when earned, and certain expenses are recognized when paid rather than when the obligation is incurred. Investments are valued at cost. Under accounting principles generally accepted in the United States, investments would be valued at fair market value and unrealized gains and losses would be recognized as part of earnings.

Investment Policy

All investments are managed by the Investment Centers of America. The portfolio consists of mutual funds and managed money. The different asset categories include cash, bonds, U.S. stocks, and international stocks. A formal review is done annually and the portfolio is rebalanced at that time, if considered necessary. The Foundation also receives quarterly updates and can request a review at any time.

Fair Value Measurements

The Foundation accounts for investments at cost in the financial statements but presents fair market value information in Note 2 for analysis purposes.

Note 1 **Summary of Significant Accounting Policies (Continued)**

Income Taxes

The Foundation is a nonprofit corporation as described in Section 501(c)(3) of the Internal Revenue Code (the "Code") and is exempt from federal taxes on related income pursuant to Section 501(a) of the Code. The Foundation is also exempt from state income taxes on related income. The Foundation's Form 990 returns for the years ended December 31, 2008, and prior years are closed to examination by the Internal Revenue Service.

Donated Materials and Services

The Foundation pays for services requiring specific expertise; however, a substantial number of volunteers have devoted significant amounts of their time in support of the Foundation. The Foundation also utilizes office space at no cost. No amounts have been reflected in the financial statements for these donated services and facilities.

Board Members

Each trustee on the Board of Trustees is elected to a three-year term by the other trustees. At the end of the three-year term, the trustee can be re-elected to another three-year term or the Board can choose to nominate a new trustee.

Subsequent Events

Subsequent events have been evaluated through April 16, 2012, which is the date the financial statements were available to be issued.

In 2009, the Foundation received a donation of \$50,000 to set up the Willis Miller Scholarship Fund. The donor designated that the Foundation award one \$2,000 student scholarship every year. The value of this fund at December 31, 2011 and 2010, was \$51,114 and \$49,774, respectively.
