- TONI EGBERT NATURIST LAW LIBRARY. NEF enhanced this online collection of legal resources on naturist topics. The library is a part of the web site of the Naturist Education Foundation and is open to all.
- GRANT. NEF issued a grant to South Florida Free Beaches for the development and production of naturist informational material to be distributed on Haulover Beach in Miami-Dade County, Florida.
- SPONSORSHIP. NEF arranged to sponsor an evening and a speaker at the UNCLAD art show in Seattle, an event that studies and celebrates the nude in art.
