	Partnering with parents/guardians, schools, corporations and others in the community, Big Brothers Big Sisters of the Fox Valley Region carefully pairs children ("Littles") with screened volunteer mentors ("Bigs") and monitors and supports them in one-to-one mentoring matches throughout their course. During 2011, we served 542 youth in our mentoring program. Total youth served in 2011, including activities organized for our waiting list youth, was 1040. The organization holds itself accountable for children in the program to achieve measurable outcomes, such as higher aspirations, greater confidence and better relationships, educational success, and avoidance of delinquency and other risky behaviors. In 2011, 57% of Youth surveyed improved their feelings of social acceptance, 62% of Youth surveyed improved scholastic competency and 40% of Youth surveyed improved their response to avoiding risky behaviors. Most children served by Big Brothers Big Sisters are in single-parent and low-income families or households where a parent is incarcerated. The average length of the agency's match is 30 months and approximately 90% of our matches last longer than nine months.
