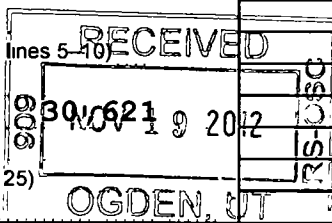

Statement of Program Service Accomplishments:

- a. Library and Archives. WCHS provides free access to a reference library collection of Wright County History which includes an archives, books, newspapers, subject files, and microfilm of newspapers, census records, naturalization records, probate records, death records and more. In 2011 a documented **1547** people visited the library, with many more that remained undocumented.
- b. Exhibit Gallery and Historic Buildings. WCHS' 3-D and archival collection are exhibited free of charge in three exhibit gallery areas and in the form of five historic structures. Each exhibit is geared to teach and communicate the history of Wright County through its artifact collection. WCHS actively collects and preserves objects and archival material related to Wright County History. In 2011 a documented **6333** people visited the museum.
- c. Museum Programs. WCHS invites the public, free of charge, to see volunteers demonstrate various historic and modern arts and crafts, household chores and agricultural skills and possibly teach the skill to others. In 2011 over **6127** people visited special programs.
- d. WCHS published a quarterly newsletter to disseminate information on Society events and articles of historic interest to its members. It also maintains a website; in 2011 there were **5041** unique visitors to the website.
