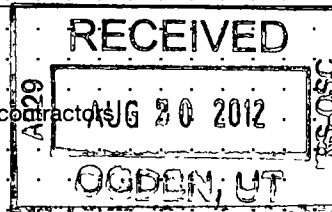

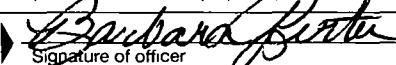

PEACE EDUCATION AND ADVOCACY educates our members, the broader community and public officials on the transforming power & practice of nonviolence, and on vital national and international issues concerning peace and justice. In 2011 over 200 people attended the Non-Violence in Islamic Traditions conference for a greater understanding of nonviolence and Islam, & about 30 people learned about the role of nonviolence in the freedom struggles in Syria in a separate speaker event. 4 newsletters were published & distributed to 269 people.

18 electronic newsletters were distributed to 2,547 people. The FNVW website, a letter writing campaign, 12 Nonviolent Communications Study Group meetings and 10 South Asia Book Group meetings reached many others FNVW engaged 450 people via Facebook

PEOPLE CAMP is a week-long experience of cooperation, community living, peace-making, & the exploration of ideas and issues. It's a family-friendly summer experience that features a warm, supportive community, with 3 challenging workshops (20 hours)& lots of recreation in a camp setting. 93 people attended in 2011.

The ALTERNATIVES TO VIOLENCE PROJECT serves inmates of Minnesota corrections facilities, residents of county jails, as well as members of the general public, by teaching non-violent conflict resolution & compassionate communication. In 2011, 426 incarcerated people participated or facilitated workshops, with 57 community volunteers.

PATHWAYS TO PEACE arose from the need for personal transformation to support people in the spiritual foundation for our work. We practice meditation, creative visualization and intention in order to nourish nonviolence in ourselves and in our world. Three volunteers have led bi-weekly sessions for a total 46 hours in 2011. This program incurred no expenses.

PEACE IN THE PRECINCTS is no longer an active program.
