A grant agreement in the amount of \$200,000 that was approved in 2010 was drawn down in its entirety in 2011, as well as a grant in the amount of \$18,178 that was both approved and drawn down in 2011. There were no approved, but undrawn loan or grant funds outstanding as of 12-31-2011.

There were five outstanding loans as of 12-31-2011. A total of \$483,512 and \$17,877 in principal and interest were repaid in 2011. Three loans were paid off in 2011.
