Saint Paul Urban Tennis provided tennis and life skills programming to over 3,000 children in Ramsey County in 2011. We do not turn any child away due to an inability to pay and keep program pricing reasonable with sliding scale fees based on household size and income. Our programs take place on tennis courts in public parks and schools, in gymnasiums at city recreation centers, and even with pop-up nets in parking lots and fields. All programs emphasize good sportsmanship and build strong character through our life skills integration. Our summer program also includes a reading component to combat the "summer slide" and ensure kids are able to pass 3rd grade reading tests.
