Trained a wide range of community groups working on multiple equity issues throughout the state. Provided staff support for the Education Equity Organizing Collaborative and developed a community partnership with state education leaders focused on creating new ways to measure and support progress towards equitable practice in schools. Supported multiple convenings of leaders within communities of color to identify policy priorities across the state. Sponosored and supported a statewide racial equity gathering to identify elements of a common agenda for equity. Created and released racial equity policy papers on jobs and wealth building and education. Researched and created a wrtten document which complied and communicated racial equity policy priorities in the state. Interviewed parents and youth and summarized results on the conditions that promote equity within schools. Researched and wrote the 2011 Legislative Report Card.
