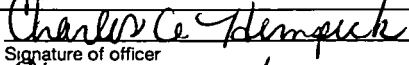

RAAN provides services to Persons Living with of Affected by HIV/AIDS (PLWHA)
In 2011, RAAN served 301 PLWHA. Of those served, 53 were new to the agency.
RAAN's partner clinics and infectious disease Specialists provided primary medical care to 185 PLWHA, who made 609 visits for medical care.
RAAN staff and partner agencies conducted 650 free rapid HIV tests. Each participant received a personal risk assessment and prevention education session.
RAAN Medical Case Managers served 235 clients with their care plans in 7379 visits or contacts
RAAN helped 99 clients access medical services and adhere to treatment regimens by paying for doctor visits and prescription medications.
31 PLWHA attended at least one meeting of RAAN's support groups in Mankato and Hibbing.
RAAN provided medical transportation to 197 clients
