



Civil rights, social action, emergency aid, and advocacy programs - democratic development. Fund grassroots organizing in various communities. Twenty-four community organizations currently make up the "Community Network for Cooperation and Solidarity." Los Olivos CIS plays a role in the campaign for water rights and the Roundtable against Metallic Mining. CIS also supports educational campaigns of SIGESAL, the public hospital workers association for medical reform and workers rights. CLEAN WATER: In 2011, Los Olivos CIS launched a "Clean Water" pilot project to provide education, training and water filtration in communities where we work. We carried out 20 trainings in 10 communities on the environment, protecting water sources, health and how to properly use filtration systems. More than 225 filtration and purification units were distributed to families and to some community centers benefitting 2,686 persons. Families were able to improve their quality of life by preventing and greatly reducing the cases of amoebic dysentery, parasites and bacteria as well as save money previously spent on medicines, bus fare, and medical consultations and missed days of work due to illnesses. Los Olivos CIS provided funding to purchase land for a water source to 23 families in the community of La Loma, Comasagua as well as inaugurate and complete the construction of a

International cultural exchange programs - educational delegations, language and cultural exchange. 33 volunteers taught English classes to 193 local community members during four nine-week English cycles. 100 international participants received Spanish instructions. 184 participants in a total of 16 international delegations/work brigades from universities, parishes, sistering relations, solidarity groups and others visited El Salvador to gain an in-depth understanding of the social and economic reality of El Salvador as well as to promote solidarity with communities and grassroots organizations working for social and economic justice.

4c (Code:) (Expenses \$ 78,389 including grants of \$ 73,230) (Revenue \$ 0)
Youth formation and Scholarship Programs - designed to develop community leaders and awareness of the young adult's role as agent for making changes for social justice. The goal of this program is to provide education to potential leaders who would not be able to study without help and at the same time build their awareness of their role in society. In 2011, this program was organized in 14 communities, providing 215 high school scholarships, 93 university. The recipients include 6 adult women involved in the small business program. Monthly leadership, formation and analysis sessions were organized for students and their parents by CIS community organizers. Topics included the environmental implication of mining in El Salvador, children and youth rights, women's rights, gender equality, sexual and reproductive rights and family planning among other themes. Many young women are pregnant and starting families at the age of 13 and dropping out of school and continuing a cycle of poverty and inequality for women; which is why the program decided to take on some of these issues. Scholarship recipients also carried out volunteer programs including imparting 9 month history of El Salvador course in 7 public schools, reforestation campaigns, overseeing clean

classroom in the "Joseph DeRaymond" school in the same village, enabling the school to attend students from kindergarten to 4th grade for the first time. **DISASTER RECOVERY:** At the end of October 2011 Tropical Storm 12 E hit El Salvador leaving communities incommunicado for more than 10 days, people unable to work for two weeks, loss of water systems and other tragedies. CIS was able to provide emergency food and clothing packages of rice, beans, sugar, corn flour, salt, cotton blankets, and clothing to over 250 families and emergency shelters in Comasagua, Isla El Espiritu Santo, Isla Colorada, Tamanique, San Vicente, and San Rafael Cedros. Los Olivos CIS was also able to provide filters to families in Comasagua where the potable water system collapsed. Families were able to collect rain water and through filtration, have a safe source of drinking water. **COMMUNITY SUPPORT:** Los Olivos CIS also contributed to school supplies to 64 youth in Romero Community in Tonacatepeque. Los Olivos CIS provided legal and moral accompaniment to the same community in face of the threat of being thrown off their land and to support the process of legalizing the titles to their land. **ELECTION REFORM:** CIS continues to be a leader on election reform. CIS hosted four public forums on election reforms including residential voting, political party regulations, plural city councils, the electoral register and other important reforms needed to strengthen transparency and participation.
